Processing of Data Concerning your Health

Sport Ireland

Sport Ireland is the data controller and will process your data under the Irish Anti-Doping Rules ("the Rules") and the World Anti-Doping Code ("the Code"). Sport Ireland's data protection officer can be contacted at dpo@sportireland.ie

Sport Ireland may process your data in accordance with the General Data Protection Regulation, the Data Protection Act 2018, the Sport Ireland Act 2015, the International Standard for the Protection of Privacy and Personal Information ("the **Standard**") and the International Standard for Therapeutic Use Exemptions.

Purpose and Legal Basis of Processing Your Data

Sport Ireland processes your data to prevent, detect and eliminate doping in sport, for the purpose of determining whether you are entitled to a TUE and any subsequent results management process under the Rules and Code. There is a substantial public interest in the prevention, detection and elimination of doping in sport and this is the legal basis for processing your data.

Your data only be used for evaluating your TUE application and in the context of potential anti-doping rule violation investigations and procedures.

Disclosing It To Other Anti-Doping Organisations

Your data will be disclosed to the Sport Ireland Therapeutic Use Exemption Committee ("TUEC") for the purpose of evaluating your application and may be disclosed as to WADA authorised staff, to the WADA TUEC and to the TUECs of other anti-doping organisations under the Code and/or the International Standard for Therapeutic Use Exemptions.

The decision of the Sport Ireland TUEC will be made available to all anti-doping organisations with testing authority and/or results management authority over you. This includes anti-doping organisations outside of the European Economic Area ("**EEA**"). WADA is headquartered in Canada which is the subject of an EU Commission adequacy decision. Other transfers outside the EEA will be subject to appropriate safeguards.

Sport Ireland will not publically disclose your data other than as provided in the Rules or the Code and only where the information is relevant to such publication.

Retention of Your Data

Your data will be stored for a period of up to ten (10) years and, when no longer relevant, your data will be deleted. If you wish to access or rectify any of your data you can contact Sport Ireland's data protection officer.

Right to Complain

If you believe that Sport Ireland is not processing your data in accordance with the General Data Protection Regulation or the Data Protection Act 2018, please contact Sport Ireland's data protection officer. At all times you are entitled to lodge a complaint with the Data Protection Commission. If you feel the Standard is not being adhered to, you may complain to WADA which will investigate the issue.
